Romania has received a loan from the International Bank for Reconstruction and Development (IBRD) and a Grant from the Global Environment Facility (GEF) to support the implementation of the Integrated Nutrient Pollution Control (the Project) in selected localities vulnerable or potentially vulnerable to the pollution with nutrients (NVZs).

The overall development objective of the project is to support the Government of Romania to meet the EU Nitrates Directive requirements by (a) reducing nutrients discharges to water bodies, (b) promoting behavioral changes at the communal level, and (c) strengthening institutional and regulatory capacity. The ultimate goal is to reduce over the long-term the discharge of nutrients and other agricultural pollutants into the Danube River and Black Sea through integrated land and water management.

The objective of the individual consultant's services is to ensure technical support to the Project Management Unit (PMU) to manage and monitor the implementation of: project's agriculture related activities and provide coordination (and collaboration as appropriate) between the Ministry of Environment, Waters and Forests and Ministry of Agriculture and Rural Development as regards the Project objectives.

The total staff days input of the Consultant is estimated at 190 to be performed within a period of engagement of 9(nine) months, starting with March 1<sup>st</sup>, 2015. The consultant is expected to start performance of the services immediately after contract signing.
