Other countries in Europe, like Finland and Great Britain, as well as the countries of CIS, all recognised the necessity of this energy source, indeed Slovakia is about to finalise its investment project of Mohi NPP.
			Romania also intends to develop Unit 3 and 4 at the Cernavoda site. I am in a fortunate position, since I was part of the Romanian delegation visited the Paks site recently, where I was personally convinced how this issue is dealt with by the Hungarian nuclear experts. I was also impressed by the simulator center of Paks NPP where the operators of the NPP are trained being unique in its sense in Europe.
